## **Notice of Academic Symposium and Call for Papers** **“Solidarity and the Family”** June 27-28, 2023, at the Faculty of Law of the Pontifical Catholic University of Chile, Santiago

The International Academy for the Study of the Jurisprudence of the Family (IASJF) is pleased to announce that it will hold its fifteenth international Symposium on **“Solidarity and the Family”** on Tuesday and Wednesday, June 27-28, 2023. The Symposium will be hosted by the Faculty of Law of the Pontifical Catholic University of Chile (Pontificia Universidad Católica de Chile) in Santiago. The Symposium will address the wide range of legal and social issues that might be relevant to, or otherwise draw upon the larger theme of solidarity in the family setting. These may include, but are not limited to, property rights, alimony, and inheritance, as well as the interplay between solidarity and other legal principles, such as subsidiarity, protection of human rights, and protection of vulnerable persons. Interdisciplinary presentations are also welcome. In addition to English-language sessions, the conference will include at least one Spanish-language session.

The IASJF is an independent, interdisciplinary scholarly society that seeks to promote thoughtful consideration and discussion of the foundations of the family, including marriage, parenting, extended and other family relations (please visit our website at <http://www.iasjf.org/>). The IASJF has previously hosted academic symposia in USA, Argentina, Israel, Spain, Malta, Qatar, Poland, Peru, the Philippines, and Slovenia among others. In the last three years *online* symposia of the IASJF have been hosted by universities in Italy, Israel and Poland.

The Faculty of Law of the Pontifical Catholic University of Chile is one of the most distinguished law faculties in Latin America. It is located at Av. Portugal 31, Santiago, <https://derecho.uc.cl/es>.

Persons wishing to present a scholarly paper at the symposium should submit a short abstract of the paper they propose (no more than 200 words) including a working title, name, institutional affiliation, and full contact information of the author(s), and a brief description of the proposed paper. Proposals should be sent to Professor Stefano Troiano ([iasjf2023symposium@gmail.com](mailto:iasjf2023symposium@gmail.com)) by April 30th, 2023. Proposals for the Spanish-language session must also be accompanied by an abstract in English. Acceptances will be on a rolling-acceptance basis.

All symposium participants must register (\$125 Academy Members, \$170 non-Members, \$100 Participants from Chile) and pay for their own transportation and hotel. Fee includes all symposium meals. An optional tour of Santiago’s surroundings (not included in the fee) is scheduled for June 29, 2023. Online registration opens on March 1, 2023.
